- A U.S citizen
- Be able to read, write, and speak English
- Is not a candidate on the ballot
- Is not related to a person on the ballot
- Is not living, permanently or temporarily, with a person on the ballot
- Is not related to another Election Judge serving in the same precinct at the same time
